**No vaccine has ever
been tested against a placebo**

Vaccines are classified as "biologics" rather than drugs, allowing less rigorous safety testing than is required for new drugs. For example, most drug trials follow 1000+ patients over months or years and use a saline or sugar placebo. In contrast, the clinical trials for Merck's Hepatitis B vaccine monitored fewer than 150 infants and children for only five days AND used other vaccine ingredients as the placebo.

In addition, vaccines are approved individually, and safety testing has not been conducted on the effects of giving children multiple vaccines in a single doctor's visit.

Infant Mortality

Compared to other developed countries, the U.S. has the most aggressive vaccination schedule during the first year of life, both in terms of number of shots and timing. Sadly, the U.S. also has the highest infant mortality rate of all industrialized countries.

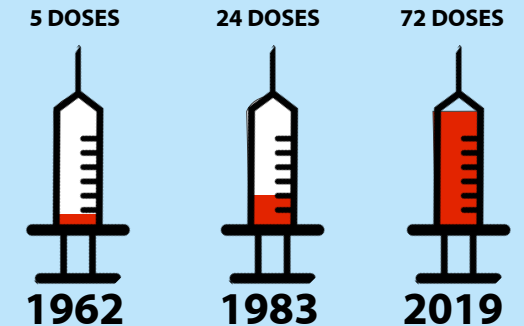
A study reported by the National Institute of Health found significant correlation between the number of vaccines and the infant mortality rates of countries. For example, Canada requires almost as many vaccines as the U.S. and also has a high infant mortality. In contrast, Japan and Sweden have the lowest number of vaccines and also have the lowest infant mortality rates in the world.

This means the CDC recommends 72+ vaccines for every human in the United States.

S.I.D.S

A U.S. Department of Health study reported a connection between Sudden Infant Death Syndrome and the vaccines routinely given in the U.S. at two and four months. This is the time frame that most SIDS deaths occur and a reported 61% of babies had received the vaccines within 12 hours to 2 weeks before death.

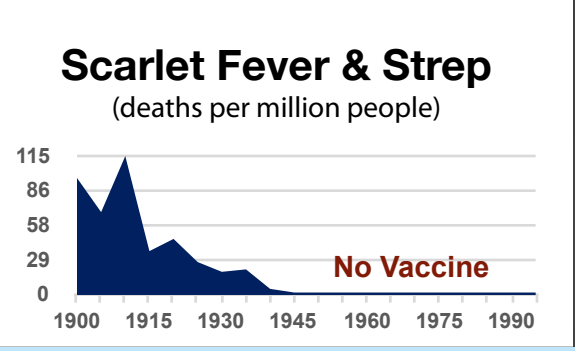
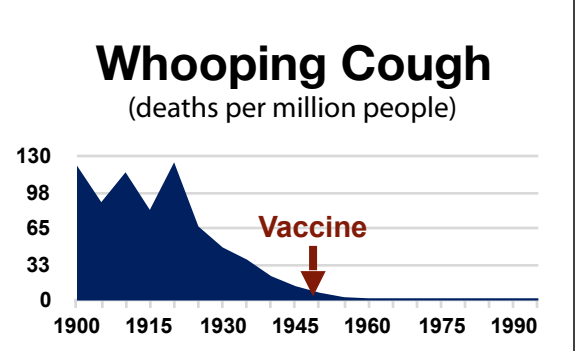
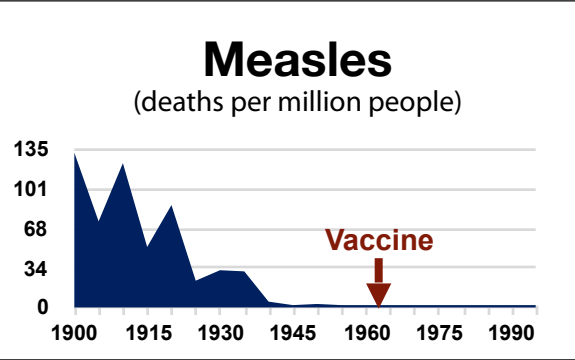

VACCINE IMPACT

HepB for NEWBORNS

Hepatitis B is a disease acquired via sexual contact or needle sharing with an infected person or can be passed from an infected mother to her baby. Despite the fact that only a very small percentage of mothers are infected, the HepB vaccine is routinely given to all babies on day of birth. One danger with this vaccine is that the dose is not adjusted for the baby's weight - it is the same amount given to adults. While the aluminum in this vaccine is

under the toxic limit for an adult, it is 7-15 times the limit for a baby, depending upon its weight.

THE CDC and BIG PHARMA

The recommended vaccine schedule is set by the CDC whose close financial ties to the vaccine industry are well-documented. The CDC routinely buys half of all childhood vaccines in the U.S. and then sells them to contracted public health agencies. The CDC's involvement with vaccine manufacturers also includes patenting, licensing agreements and collaboration on projects to develop new vaccines. In fact, the CDC and its employees hold over 50 profit-generating patents relating to vaccines, a clear conflict of interest.

Merck, the sole manufacturer licensed by the FDA to sell the mumps vaccine, is being sued by former employees for allegedly selling a mumps vaccine that was mislabeled, misbranded, adulterated and falsely certified as having an inflated efficacy rate.

There also appears to be a "revolving door" between the CDC and various pharmaceutical companies. Perhaps the most notable example is that the head of the CDC from 2002 to 2009, Julie Gerberding, left her government job to go work as president of Merck's \$5 billion global vaccine division. More recently in January 2018, CDC Director Brenda Fitzgerald was forced to resign after it was revealed that she bought tens of thousands of dollars in new stock holdings in companies including Merck, one of the largest vaccine manufacturers in the U.S.

VACCINE INJURY

As with all pharmaceuticals, vaccines come with manufacturer inserts which provide a long list of known, serious adverse reactions. These extensive inserts, which are not presented to parents, include reactions such as diabetes, asthma, celiac and other autoimmune diseases, long-term seizures, coma, permanent brain damage, Guillain-Barré Syndrome, deafness, encephalitis and meningitis.

Despite the long list of possible serious reactions, manufacturers are not held liable for vaccine injuries because of the National Childhood Vaccine Injury Act, passed by Congress in 1986. This act declared that vaccines were "unavoidably unsafe" and created the Vaccine Adverse Event Reporting System (VAERS) and the National Vaccine Injury Compensation Program (VICP). Although it is estimated that less than 1% of serious reactions are ever reported, the VICP has paid out over

\$4 billion in compensation since inception.

After removal of liability from vaccine manufacturers in 1986, new vaccines were added to the CDC schedule at a rapid rate. With no liability, reduced testing requirements and little marketing costs, vaccines have become the "cash cow" of the pharmaceutical industry.
