In accordance with the Texas Public Information Act ("Act"), Chapter 552 of the Texas Government Code, the City of Plano makes its public records available to citizens.

The City of Plano will respond within ten business days to request for public information. The request must ask for records or information already in existence at the time the request is made. In some instances, the City may seek a request for option from the Texas Attorney General in order to determine whether parts or all of the information requested can be withheld in accordance with certain exceptions provided within the Act. Examples of such exceptions include matters relating to homeland security, third party personal privacy considerations and juvenile records. In such matters, the City will provide the requestor notification in accordance with state law. It is also important to note that the Act does not require governmental bodies to create new information, perform legal research, or to answer questions.

The City of Plano may collect a fee for the processing of records requests. This fee may be applied in accordance with the Act or as prescribed by other law or regulation that govern the category of documentation requested.
