Good afternoon Dr. Wright,

I think that the three attached e-mails should help in re-orienting you to the community water fluoridation topic.

- May 14, 2020 correspondence this e-mail to CAPT Dulaigh contains the draft SG statement that Dr. Rollins and I developed in February 2019 for VADM Adams. At the time, he didn't want to sign such a statement because NTP was developing a monograph on fluoride that would undercut our long-standing support. However, that report had major methodological flaws according to a NASEM review.
- 2. May 20, 2020 correspondence this e-mail to CAPT Dulaigh provides an overview of the NTP monograph and the NASEM review and is a great background.
- 3. Yesterday's correspondence this is the request to have me sign a statement of support done by the 8 living former USPHS chief dental officers. This would be independent of VADM Adams' statement; I just need approval to endorse fluoridation by signing this letter.

Bottom line: now is the perfect time for a statement of support for fluoridation. We are celebrating the 75<sup>th</sup> anniversary, and every past SG has supported fluoridation. Attached are statements of support by SGs Benjamin, Carmona, Murthy, and Satcher, if that helps. In addition, fluoridation will be in the SG's Report on Oral Health when it is released and it is one of the 11 oral health objectives in Healthy People 2030, so I can't imagine a reason that the SG wouldn't want to sign it.
