

I Wish I Had Known...



One of the most common thoughts we hear from parents of vaccine-injured children is, **“I wish I knew then what I know now.”** These well-intentioned parents trusted the recommendations of their children’s medical providers and the conventional wisdom of mainstream medicine, which follows the vaccination guidelines of our government health agencies. Unfortunately, for so many of these families, the “one size fits all” vaccination policy — in place then and now — has had disastrous consequences. **Please share these insights with your family and friends.**

I wish I had known...

- The real risks of vaccines. When the injury happens to my child, **the risk is 100%.**
- **Some kids are more vulnerable to vaccine injuries.** Not everyone can take penicillin. Why should I assume my child can take all vaccines and be ok?
- A DTaP vaccine means a **lifetime of greater pertussis susceptibility.**
- **Vaccine effectiveness wanes over time,** which leads to a lifetime of revaccination with unknown side effects and health outcomes.
- Vaccine manufacturers have no product liability, and **the government has paid over \$5 billion for vaccine injuries.**
- The Institute of Medicine concluded in 2013 that **long-term safety studies** of the cumulative effect of the entire CDC-recommended vaccine schedule for children **have never been done.**
- **SIDS deaths frequently occur soon after** the administration of vaccines at the 2 and 4-month well-child visits.
- Studies funded by the U.S. Department of Health and Human Services (HHS) indicate that the **Vaccine Adverse Event Reporting System (VAERS) reflects less than 1% of true vaccine injuries.**
- The same **companies that have paid over \$82 billion in fines and penalties** since 2010 are the manufacturers I’m **supposed to trust** with my child’s vaccines.
- Some vaccines, like COVID-19 shots for children, **may cause more injuries and deaths** than the diseases themselves.
- Immune activation during pregnancy likely **increases the risk of neurodevelopmental issues** like autism in babies.
- **Toxins (like aluminum and mercury) in vaccines often exceed federal safety guidelines,** and those ingredients are linked to childhood health conditions and autoimmune diseases.
- HHS broke the law by **not submitting vaccine safety reports to Congress** for over 30 years!

- Vaccines are incentivized, and **pediatricians often get a bonus for complying with CDC vaccination recommendations**, which now include COVID-19 shots.
- **The science isn't settled on vaccines**; it is corrupt ... they stole the "Tobacco Science" playbook.
- **No one knows the long-term health consequences** of injecting vaccines into children's bodies.
- **54% of our children are now suffering from a chronic health condition**, and many of those diseases are linked to vaccinations.
- **None** of the federally recommended childhood vaccines **has been tested against a true inert placebo** in pre-licensure studies.
- Several independent peer-reviewed studies have concluded that **unvaccinated children are healthier than vaccinated children**.
- **CDC owns over 50 vaccine-related patents**. Isn't that a conflict when they encourage me to vaccinate my child?
- Vaccine safety advocates have nothing to gain from pointing out the risks, while **the vaccine industry will be worth \$48 billion by 2025**.
- **Seizure disorder and autism have been compensated** as vaccine injuries by the government.
- Hepatitis B disease affects primarily "high-risk" adults, but **Hep B vaccination targets low-risk infants** and school children for "convenience."
- There's no "do-over" with vaccines. Once the injury happens, there is no cure, and **injuries are often lifelong**.
- **Mortality** from the diseases we vaccinate against **was already declining** by the time their vaccines were created.
- There is a **CDC scientist turned whistleblower who says CDC destroyed science** indicating MMR caused autism in African American boys.
- The **FDA didn't rely on any vaccine safety trials** before recommending influenza and COVID-19 vaccines for pregnant women.
- Hep B is transmitted by IV drug use, through unprotected sex or from a Hep B-positive mother to her baby. Therefore, **more than 99% of infants who receive this vaccine are at no risk of acquiring the disease** — 0.00267% of all infants born in the U.S. annually will contract the virus at birth.
