So, let's settle down, people!!! Remember: America is supposed to be "Land of the Free, Home of the Brave." Pharma and its media shills are working at turning us into "Land of the Cowed, Home of the Slave."

A DOZEN FACTS you won't learn from MSPharmedia:

- 1) Measles is usually a mild, self-limiting childhood illness.
- 2) Since 2000, there have been nine reported measles deaths in the U.S. Since 1986, there have been 415 deaths associated with the MMR vaccine according to the Vaccine Adverse Event Reporting System.
- 3) In 1962, the CDC attributed <u>408</u> deaths to measles out of a population of <u>186 million</u> (risk=2/1,000,000—about <u>double</u> the risk of dying from lightning).
- 4) The risk of measles mortality is much higher among <u>malnourished children</u>; contemporary science suggests that vitamin A can reduce this risk by over 80%.
- 5) "Natural" vitamin A cannot be <u>patented</u> so Pharma has no interest in promoting it.
- 6) Unlike Merck's MMR vaccine, wild measles infection confers <u>lifetime immunity</u> from measles. Having measles in childhood may also reduce the risk of <u>atopic disease</u>, <u>heart disease</u>, <u>Hodgkin's and non-Hodgkin's lymphomas</u> and some other <u>cancers</u>.
- 7) Meanwhile, the MMR is associated with seizure rates <u>five times greater</u> than associated with wild measles, as well as <u>brain damage</u>, <u>encephalitis</u>, <u>Crohn's disease</u>, <u>ulcerative colitis</u> and <u>dozens</u> of other serious adverse events.
- 8) Half the kids in <u>Merck's clinical studies</u> suffered serious gastrointestinal problems within 42 days of the jab.
- 9) Merck's MMR vaccine provides <u>meager maternal antibodies</u> to protect infants in their first year when they are too young for the vaccine, putting babies at risk for brain damage and death.
- 10) Contrary to Merck's promise, the MMR rarely provides lifetime immunity, putting postpubescent adults at heightened risk for serious injury or death.
