Re: exposed to 4 Hepatitis B vaccine shots

Honorable President Joe Biden,

I am writing to you seeking help for my daughter who was vaccinated with four Hepatitis B vaccine shots for which there is limit data in regards to safety. I was not aware that she will get 4 shots of hepatitis B. After she developed seizure disorder at 9 months, (seizure disorder being side of Pediarix vaccine given to her 3 times) my husband and I took her to numerous doctors, hospitals, research the internet and her medical records. Recently we realized that she was exposed to experimental vaccination which violates the Nuremberg Code (all medical procedures and therapies must be fully informed and fully consented).

She developed bloody rash after the 2-month vaccinations, continued to be vaccinated at 4 and 6 months and she developed seizure disorder at 9 months. She has been hospitalized several times. Her genetic testing was negative for comprehensive epilepsy panel, therefore epigenetic factors caused her symptoms. Studies concluded that hepatitis B vaccine may induce impairments in behavior and hippocampal neurogenesis while her EEG reports mention mid temporal (hippocampus) spikes, the 5<sup>th</sup> Grade report card says that "*Laura continues to struggle with mastering foundational skills due to her difficulties to retain learned skills*") and Th2 immune activation (seizure taking place within 45 minutes after meals).

It looks that my daughter was exposed to experimental vaccination which could have caused her seizure disorder similar to German physicians who conducted deadly experiments during World War II. It is well known that who has seizure disorder has high risk of dying sooner.

My daughter came in this life innocent and I took her to the pediatrician for care. She was exposed to experimental vaccination and also was continued being vaccinated even

though she developed allergy symptoms after the 2-month vaccination and I expressed my concern about the allergy.

My daughter asks every day why she has seizure after meals, what happened with her.

My husband or I have to be one arm close to her at all times. We do not get financial support. Even though we are heartbroken and overwhelmed, we are responsible and we work to support our family.

I emailed and faxed my daughter's situation to NYC officials but I have not heard from anybody. Attached is the recent letter faxed to NYC officials. Enclosed please find birth record showing Hepatitis B vaccine given at birth and childhood vaccination records including the 3 shots of Pediarix.

All life matters. We are seeking evaluation of her case.

I am looking forward to hear from you.
